Maryland PLANT Community - Awards Program

The <u>People Loving And Nurturing Trees (PLANT)</u> award is recognition for communities who care for their trees. Communities of all types can receive the award—schools, HOAs, parks, local governments, government facilities, scout troops and churches, just to name a few.

Your Community is probably already at one of the four levels of the PLANT Award program. Choose the level you feel best fits your community's activities in the last year. Over time your community can see your program grow, as your award level increases. The reviewing committee will look at your submitted documentation and then award the best fitting level!

The Maryland Urban and Community Forestry Committee of the Maryland Forestry Boards in partnership with the Maryland Department of Natural Resources sponsor this program and review the applications. **Applications and supporting documentation are due in January.** Awards are mailed in mid-March so that you have it in time for Arbor Day celebrations in April!

There are four PLANT award levels: Bronze, Silver, Gold, and Green. Successive levels require more formalized tree care activities. Although a community may remain at any level for an unlimited number of years, the goal of the program is to encourage a community to grow through the award levels by strengthening their commitment and care for their urban trees. The Town of Riverdale Park has been awarded at the Green level for 2019.

Awards are given based on the number of accomplishments completed by the applicant during the award year. A minimum of 4 accomplishments is required to be recognized. Acceptable accomplishments for **PLANT** awards range from holding a one-time tree event or ceremony (Arbor Day) to having built comprehensive ongoing planting and maintenance programs. **PLANT** is sponsored by the Maryland DNR Forest Service and the Maryland Community Forestry Council.
